Happy 2015! In reflecting over 2014, I have made some observations over the past year and would like to address a few things:

- Detachments are losing ground and members due to lack of communication. Communication is the key to any organization. If you do not have an email chain, **get one!!!** Even if you have members without email, someone can be assigned to spread word to them. When members are not informed of things that are going on, they feel slighted and are less likely to help out with anything.

(North, Central, East), excluding the JA of the detachment where the grievance originates. The National JA would like feedback from the Departments to see how the committees work out.

I am sure the other detachments in the District have been busy as well, and I ask all detachment Commandants to include me in on their newsletter and email lists.


## Eastern District Vice - Donald Benson, Sr.

# DEPARTMENT MARINE OF THE YEAR - NOMINATION GUIDANCE

1. The local Detachment decides to nominate a **Regular Member** (dues must be current) who has been active in the Detachment. *Sorry, Associate and Honorary members are not eligible.*
2. A Detachment meeting is held. The members assembled take a vote on the Regular member who they desire to nominate for the Department MOY Award. It shall be approved by a majority vote.
 

Note: it is recommended that the “Letter of Nomination” or a list of the nominee’s accomplishments be read aloud at the meeting so every member has a chance to understand what the nominee has done to warrant his/her nomination.
3. Complete a Letter of Nomination to include a Statement of Certification from the Detachment Commandant and Detachment Adjutant stating the nominee was approved by the Detachment by a majority vote.
 

Note 1: In the event the nominee is the Detachment Commandant, the Letter of Nomination shall be signed by the Senior Vice Commandant and the Adjutant.

Note 2: In the event the nominee is the Detachment Adjutant, the Letter of Nomination shall be signed by the Detachment Commandant and Senior Vice Commandant.
4. The Letter of Nomination shall include a listing of the nominee’s accomplishments at the local Detachment and may include any other Marine Corps League accomplishments at the Department or National level.
5. Each nomination submitted shall be placed in a sealed envelope and addressed to:
 

“Chairperson, Department Marine of the Year Committee”
6. Place that envelope into another envelope (**YES...2 envelopes**) labeled:

7. **If you choose to MAIL your nomination:** mail using the US Postal Service **Certified Mail with Return Receipt Requested** It **must** be postmarked no later than the Monday preceding the Department Spring meeting in March.
8. **If you choose to DELIVER IN PERSON** do so to the Department Commandant **PRIOR** to the start of the Department Spring meeting on 7 March.
9. Nominees should plan to attend the Department Convention Banquet which is held on the Saturday night of the annual Department Convention.
10. Additional questions should be directed to the Department Commandant or one of the Past Department Marine of the Year recipients.
