MVC Quarterly Meeting

On Tuesday 16 July 2024 the Maryland Veterans Commission held the Summer quarterly meeting at American Legion Talbot Post 70 29511 Canvasback Drive, Easton, MD. in person and by phone with 24 Commissioners representing VSOs and congressional districts, representing the Marine Corps League was Commissioner Stuart Blair, PDC...

MDVMF Secretary Anthony Woods: Update on the Department:

- The Fiscal Year ended on June 30th, so I will provide some updates for the past year.
- As of July 1st, we are now the Department of Veterans & Military Families. Dana Burl has been promoted to the Deputy Secretary of the Military Families Program

Service and Benefits Program:

- DVMF filed 5,076 claims in FY 24, the most since 2016, with an approval rate over 90%.
- Over 44 million in monetary benefits were awarded to veterans, their dependents and survivors represented by DVMF in FY 24.
- The service program added new locations at the Elkton Motor Vehicle Administration and the VA Community Based Outpatient Clinic in Eastern Baltimore County in FY 24.
- We have hired additional staff at the Glen Burnie and Frederick offices and they will start later this month. We are also planning another hire for the Gaithersburg office.

Communications, Outreach & Advocacy

- The Communications team increased social media efforts tremendously in FY24 resulting in 218,000 social media views.
- Ask the Question and suicide prevention trainings have now been facilitated to 425 federal, state, and local government and community partners.
- Website updates have been made to reflect the name change.
 - If you find an update that was missed, such as a PDF attachment, please email Dana or Denise.
 - In addition, all State Public Information Officers have been asked to update their Department websites throughout State government.
 - Please notify your own Veterans Service Organizations of the change so their websites can be updated as well. If new logos are needed, please let Dana or Denise know.
- We are required by legislation to use existing marketing materials before ordering new ones with the name change. If you have materials, please use them up and then let us know when you run out.
- The first meeting of the new Commission on Veteran and Military Families met July 11.
 - Meetings will convene monthly for the duration of the calendar year and the report on making Maryland the best state for veterans and military families is due to the MGA and GOV by December 1.

 A multidisciplinary team has been convened to research and write the plan. Two MVC commissioners are represented, Chairman Tyler and Commissioner Spiegel. Dana is the chair.

Maryland Veterans Trust Fund

- A new grant administrator was hired, and we will soon hire an accountant.
- We are converting from paper grant applications to an online grants management system.
- Our trustees approved the addition of organizational grantmaking.
 This will eventually be a tool to make grants to other nonprofits that similarly provide support to veterans and their families.
- Our grant administrator and grant specialist are working on strategies to address the application queue backlog. We aim to invite veterans eligible for grants to a soft launch of the grant database in late Summer.
- We will implement new data collection and impact measures for the Trust Fund.
- We will deepen partner relationships with our donor agencies to ensure consistent revenue streams.

Charlotte Hall Veterans Home

- Charlotte Hall website has been updated.
- CMS quality rating has increased to three stars.
- Charlotte Hall has been awarded the 2024 (American Health Care Association/National Center for Assisted Living) AHCA/NCAL Bronze National Quality Award.
- CHVH received a gold star from the Maryland Healthcare Commission for its administration of flu vaccinations for 2023-2024.
- The census at Charlotte Hall has increased to 253, which is the highest in over a year.
- Moving to more permanent staff and less contract and agency staffing.

 The Joint Commission on Accreditation of Healthcare Organizations will survey Charlotte Hall in August (survey at our request).

Cemetery & Memorials Program

- There will be no Unaccompanied Veterans ceremony this quarter, as there were no unclaimed veterans. The next one is scheduled for October 25th pending receipt of eligible unclaimed cremains.
- An erosion control and beautification project was recently completed at Vietnam Veterans Memorial.
- Crownsville Superintendent Pat Ritter retired after 26 years of State service. We are grateful for all she's done for the Veteran community and wish her well in her retirement.
- Keith Brown, who formerly directed the Memorials program has been promoted to the Deputy Director of the Cemeteries & Memorials program.

Subcommittee Reports

Homeless Subcommittee – Commissioner Reuter provided the following report:

- The Annual count in time was canceled this year due to weather
- Speaking of weather, the current heat wave is affecting everyone and

people who have no place to go are especially vulnerable. So far there have been no reports of any Homeless Veterans who have died because of the heat. The fire dept reports many (over 60 per day) heat related hospital runs and so far no deaths and no reports of any veterans.

- While the actual number of homeless veterans is unknown but is reported to be stable neither growing nor shrinking.
- the current number of HUD VASH vouchers is static with more comingin the future (more on this below).
- The VA Medical system has had the federal rules of eligibility changed so, persons with "less than honorable" discharges to potentially able to use the VA medical system, Many Homeless persons fall in this category so getting the word out is high on list of priorities, take DD 214 to VA hospital to have it verified at the registration center just to the left of the entrance.
- The VA Annex on Fayette Street is the location where most services for veterans who are homeless are located, unfortunately this facility was closed for about a month due to damage at the BUILDING NEXT DOOR to the Annex not the Annex itself. Note: the building has now reopened.
- Everything has been repaired and the building stabilized and has reopened with ALL services resumed.
- Now about those HUD-VASH vouchers, 50 more housing units are almost finished at the Freedom Village on the Perry Point hospital campus. These will come with HUD VASH vouchers so there will be 50 additional family friendly units at the facility.

PUBLIC AFFAIRS OFFICER

First things first, the Blanton's Bourbon raffle winner be announced today. We did very well in this effort and we thank you for this effort.

At our recent convention I spoke to several officers and members about the possibility of conducting a Pistol Match at the range where I work as an RSO, Queen City Armory in Cumberland, Md. Our range was built by Action Targets of Utah. We have 10 lanes with a shooting distance of 25 yards. The individual lanes are controlled via an I-Pad. Our range is rated up to .50BMG and we have tested that standard.

The course of fire for this event is simple. This event consists of 50 rounds fired as follows.

5 rounds - Sighters 10 yards

15 rounds - Shoot- No-Shoot drill 12 yards

15 rounds - Charging Drill 40 Ft

15 rounds - Charging Drill 40 Ft w/ Magazine change

There will be a scorer/coach with each shooter on the firing line

Allowable weapons are any Centerfire Semiautomatic Pistol or Revolver. That means for a Highpoint 9mm up to a Magnum Research BFR in 45-70 Government. All we care about is that you fire the weapon safely.

In the Shoot-No-Shoot drill the target goes downrange 12 yards. The target will then flip front to back repeatedly. The target will momentarily stop on either on the white backing or the target. Shoot the target not the white backing.

For the charging drill the target goes downrange 40 feet. Once there the target charges at the shooter. The shooter's goal is to accurately fire 5 rounds at the attacker. This charge repeats itself 3 times. For the magazine change set of charges, the shooter has to change is magazine. The scorer/coach will load these magazines.

For this shoot we have to have a minimum of 25 shooters. Cost is \$25 per shooter. Rental weapons are available for use at a fee.

We encourage the detachments to contact veterans' centers at Local College and Universities. This event can be used as a recruiting tool to bring in younger veterans into your Detachments.
